RMKS/1. THE FOLLOWING ITEMS PERTAIN TO NAVY POST OFFICES:

- A. PAGES 18-22, OVERSEAS MILITARY MAIL-CONDITIONS APPLIED TO MAIL ADDRESSED TO MILITARY POST OFFICES OVERSEAS-POST AT ALL FINANCE WINDOWS.
- B. PAGES 35-36, INTERNATIONAL MAIL MANUAL (IMM) REVISION-CHANGES IN MAILING ITEMS TO NORWAY. EFFECTIVE 28 FEBRUARY 2003, THE POSTAL SERVICE'S EUROPEAN DELIVERY AGENT, GENERAL LOGISTICS SYSTEMS (GLS), WILL NO LONGER DELIVER AIRMAIL PARCEL POST IN NORWAY. THIS CHANGE AFFECTS WEIGHT AND SIZE LIMITS FOR PARCEL POST, THE AVAILABILITY OF INSURANCE AND RETURN RECEIPT SERVICE, AND PROHIBITIONS, RESTRICTIONS, AND OBSERVATIONS. READ THIS ARTICLE AND MAKE APPROPRIATE REVISIONS TO ISSUE 28 OF THE IMM.
- C. PAGE 37, INTERNATIONAL MAIL MANUAL ISSUE 28-COPIES OF INTERNATIONAL MAIL MANUAL (IMM), ISSUE 28, (DATED JANUARY 2003) WERE RECENTLY SHIPPED TO ALL NAVY POST OFFICES. ALL PREVIOUS ISSUES OF THE IMM ARE OBSOLETE AND SHOULD BE RECYCLED UPON RECEIPT OF ISSUE 28.
- D. PAGES 44-46, INVALID EXPRESS MAIL CORPORATE ACCOUNT NUMBERS-POST AT ALL SHORE BASED FINANCE WINDOWS.
- E. PAGES 47-54, MISSING, LOST, OR STOLEN U.S./CANADIAN MONEY ORDER FORMS AND COUNTERFEIT CANADIAN MONEY ORDER FORMS-POST AT ALL FINANCE WINDOWS.
- F. PAGES 76-79, PHILATELY STAMP ANNOUNCEMENT 03-08 AND 03-09 -INFORMATION FOR COPEs, PFOS, AND STAMP COLLECTORS ON THE NEW PELICAN ISLAND NATIONAL WILDLIFE REFUGE COMMEMORATIVE STAMP, AND SEA COAST NONDENOMINATED, NONPROFIT STAMP.

G. PAGE 91, RETAIL ASSOCIATES-KEEP THE MAIL SAFE-THIS ARTICLE  
REMINDS FINANCE CLERKS THEY PLAY A ROLE IN ENSURING THE SAFETY AND  
SECURITY OF THE MAIL, AND THEY MUST ASK CUSTOMERS IF ITEMS BEING  
MAILED CONTAIN ANYTHING LIQUID, FRAGILE, PERISHABLE, OR POTENTIALLY  
HAZARDOUS. REQUIRE ALL FINANCE CLERKS READ THIS ARTICLE AND POST AT  
ALL FINANCE WINDOWS.//
