- B. PAGE 24, DMM REVISION-CLARIFICATION OF OTHER NONMAILABLE MATTER-DMM C010.10.2 IS REVISED TO CLARIFY THE HANDLING OF OTHER NONMAILABLE MATTER. READ THIS ARTICLE AND MAKE APPROPRIATE CHANGES TO ISSUE 58 OF THE DMM, SECTION C010.10.2.
- C. PAGES 40-41, INVALID EXPRESS MAIL CORPORATE ACCOUNT NUMBERS-POST AT ALL SHORE BASED FINANCE WINDOWS.
- D. PAGES 42-50, MISSING, LOST, OR STOLEN U.S./CANADIAN MONEY ORDER FORMS AND COUNTERFEIT CANADIAN MONEY ORDER FORMS-POST AT ALL FINANCE WINDOWS.
- E. PAGE 51-55, OVERSEAS MILITARY MAIL-CONDITIONS APPLIED TO MAIL ADDRESSED TO MILITARY POST OFFICES OVERSEAS-POST AT ALL FINANCE WINDOWS.
- F. PAGE 69, IMM REVISION-COMPLIANCE DATE FOR NEW CUSTOMS FORMS RESCHEDULED TO APRIL 4, 2004-PB 22116 NOTED NEW INTERNATIONAL MAIL CUSTOMS DECLARATION FORMS MUST BE USED STARTING MARCH 1, 2004. HOWEVER, THE MANDATORY COMPLIANCE DATE WILL NOW BE APRIL 4, 2004. EFFECTIVE THIS DATE ENSURE ONLY PS FORMS 2976, 2976-A, AND 2976-E WITH JANUARY 2004 EDITION DATES ARE USED.
- G. PAGES 73-74, PHILATELY STAMP ANNOUNCEMENT 04-05-INFORMATION FOR COPES AND PFOS ON THE NEW 37-CENT UNITED STATES AIR FORCE ACADEMY COMMEMORATIVE STAMP.
- H. PAGE 75, STAMP STOCK ITEMS WITHDRAWN FROM REGULAR SALE AND FROM SALE AT PHILATELIC CENTERS-EFFECTIVE CLOSE OF BUSINESS MARCH 31, 2004, ALL MPOS MUST WITHDRAW THE STAMP STOCK ITEMS AND PRODUCTS LISTED ON PAGE 75 AND PREPARE THEM FOR RETURN TO THE APPLICABLE POSTMASTER/PFO.
- I. PAGES 91-93, PUB REVISION-PUB 247, SUPPLY AND EQUIPMENT CATALOG-EFFECTIVE NOVEMBER 1, 2003, PUB 247 WAS REVISED TO REFLECT CHANGES PERTAINING TO ORDERING RUBBER AND STEEL HAND CANCELING STAMPS. READ THIS ARTICLE AND MAKE APPROPRIATE CHANGES TO POST OFFICE COPIES OF PUB 247. NAVY POST OFFICES IN NEED OF RUBBER AND STEEL HAND CANCELING STAMPS MUST ORDER THESE ITEMS FROM JOINT MILITARY POSTAL ATLANTIC OR PACIFIC, AS APPROPRIATE.//
