- A. PAGES 36-37, INVALID EXPRESS MAIL CORPORATE ACCOUNT NUMBERS-POST AT ALL SHORE BASED FINANCE WINDOWS.
- B. PAGES 38-46, MISSING, LOST, OR STOLEN U.S./CANADIAN MONEY ORDER FORMS AND COUNTERFEIT CANADIAN MONEY ORDER FORMS-POST AT ALL FINANCE WINDOWS.
- C. PAGES 47-51, OVERSEAS MILITARY MAIL-CONDITIONS APPLIED TO MAIL ADDRESSED TO MILITARY POST OFFICES OVERSEAS-POST AT ALL FINANCE WINDOWS.
- D. PAGE 65, DMM REVISION-INSURED MAIL, RETURN RECEIPT, AND RESTRICTED DELIVERY-ELIGIBLE MATTER-EFFECTIVE 01 APR 04, DMM SECTIONS S913.1.2, S915.1.2, AND S916.1.2 ARE REVISED TO CLARIFY WHAT TYPES OF MAIL MATTER ARE ELIGIBLE FOR INSURED MAIL, RETURN RECEIPT, AND RESTRICTED DELIVERY SERVICES. READ THE ARTICLE AND MAKE APPROPRIATE CHANGES TO ISSUE 58 OF THE DMM.
- E. PAGES 71-73, HANDBOOK F-1 REVISION-INTERNATIONAL REPLY COUPONS-IN THIS ARTICLE, USPS PROVIDES GUIDANCE TO THEIR OFFICES ON THE DATES AND LOCATIONS TO WHERE EXCHANGED FOREIGN-ISSUED AND U.S.-ISSUED REFUNDED INTERNATIONAL REPLY COUPONS (IRCS) MUST BE SUBMITTED. COPEs TRANSMITTING 1412 REPORTS DIRECT TO USPS MUST SUBMIT IRCS TO THE RESPECTIVE SDO OFFICES IN NEW YORK AND SAN FRANCISCO BY THE END OF FEBRUARY EACH YEAR. COPEs WHO DO NOT TRANSMIT 1412 REPORTS TO USPS MUST SUBMIT IRCS TO THE SERVICING POSTAL FINANCE OFFICE (PFO) BY THE END OF JANUARY EACH YEAR. PFOS WILL CONSOLIDATE THE IRCS AND SHIP THEM TO POSTMASTER, NEW YORK, OR POSTMASTER, SAN FRANCISCO, AS APPROPRIATE.
- F. PAGES 79-80, PHILATELY STAMP ANNOUNCEMENT 04-06- INFORMATION FOR COPEs AND PFOS ON THE NEW 37-CENT HENRY MANCINI COMMEMORATIVE STAMP.
- G. PAGES 92-93, SETTING CLOCKS ON IRTS FOR DAYLIGHT SAVINGS TIME-DISREGARD THIS ARTICLE, GUIDANCE ON SETTING CLOCKS IN IRTS AT MILITARY POST OFFICES WILL BE PROVIDED BY THE MILITARY POSTAL SERVICE AGENCY.//
