Subj: CONSOLIDATED MAIL CONTAINERS

Encl: (1) Copy of PS Label 228 and PS Tag 14

1. Periodically the Navy Official Mail Manager receives information that the U.S. Postal Service (USPS) is opening consolidated mail containers. This causes a delay in delivery of the contents, and sometimes mail is returned to originator, and/or the USPS tries to charge postage on the contents of the container.
2. This problem is a result of the dispatching mail center failing to properly label the consolidated containers, or to attach a PS Tag 14, All For Firm on Sack Label, to a pouch of consolidated mail.
3. Request you bring to the attention of your command Official Mail Managers(OMMs) and mail center supervisors at locations that process outgoing mail the necessity of labeling containers properly and affixing PS Tag 14 to pouches. Also, PS Tag 14 must be securely affixed to ensure it does not detach in transit. Slide labels in pouches must also reflect the complete mailing address of the receiving mail center.
4. Enclosure (1) provides an example of the correct way to address consolidated containers using PS Label 228 and a copy of PS Tag 14.


