SHIPMENTS TO GUANTANAMO BAY, CUBA

 Accompanied member/employee Household Goods (HHG) shipments to Naval Station Guantanamo Bay (NSGB) request an APPROVED Dependent Entry Approval (DEA) from the Housing office on island. 2) HHG shipment is not authorized until DEA reflects member has been assigned permanent housing and is authorized shipment of HHG.

Weight Restrictions

1) Weight allowed to be shipped is determined by members orders.

Furniture, Oversized

- 1) It is highly recommended that members speak to their command sponsor prior to arranging HHG shipment to Guantanamo Bay, Cuba.
- 2) Majority of housing units are small (950-1150 sq ft) with limited storage.
- 3) Reassignment to accommodate HHG will not be authorized.
- 4) Waterbeds are not authorized in two-story housing units.
 - a) The family housing office encourages all incoming residents to consult with them prior to arranging waterbed shipment.

- 5) Hot Tubs, SPAs and Jacuzzi: Not recommended due to climate.
- 6) Pianos and Organs: There are no third party tuning or repair services available. Highly recommend these items not be shipped to Guantanamo Bay.

Pets/Quarantine

- Only dogs and cats and no more than two total pets can be transported to Guantanamo Bay, each way, unless a waiver is approved from AMC Passenger Reservations Center, Scott AFB, Illinois.
- 2) There is no quarantine required at Guantanamo Bay.
- 3) Ensure all vaccinations and immunizations are up to date prior to transporting the pet(s) to Guantanamo Bay, Cuba.

Privately Owned Firearms (POFs)

- 1) Shipment of firearms is prohibited, to include toy related guns.
- 2) Any privately owned firearm found to be in a shipment of HHG will immediately be confiscated and will be shipped back to CONUS at owner's expense.
- 3) Adequate storage of a privately owned firearm is not available.

Privately Owned Vehicles (POVs)

- 1) IF authorized on orders, following documents are required for POV shipment:
 - a) Copy of Title or
 - b) Lien Letter and Registration Lien Letter must state authorized to ship to Guantanamo Bay, Cuba,

- i. It will be rejected, if it only states, authorized to ship to Cuba.
- c) VI St. Croix and St. Thomas Copy of Title or Lien Letter and Registration Copy of Driver License Actions
- 2) POVs (Includes data on prohibited vehicles, color, etc.)
 - a) No year restriction for vehicles ship to NAVSTA Guantanamo Bay Cuba.
 - b) Only one POV authorized to be transported at GOV'T expense.
 - c) POVs being shipped to NSGB may be driven directly to the water port terminal, Schuyler Lines Portus, 8998 Blount Island, Jacksonville, FL, 32226.
- 3) The member should have travel orders, driver's license, auto insurance card, and ID card to present to terminal POV processors.
 - a) Call prior to arrival to confirm hours of availability, last minute instructions, and driving directions.

Gasoline/Catalytic Converters

- 1) Only regular unleaded gasoline and diesel fuel are available.
- 2) Catalytic converters do not need to be removed.

Insurance and Safety Requirements

- 1) Insurance is available locally if member's insurance company does not provide overseas coverage.
- 2) Vehicles must pass safety inspection covering lights, signals, brakes and horn.

Transmitting Equipment

CBs/MARS equipment:

Must be registered with COMNAVBASE prior to use.

Other

- 1) GOVERNMENT QUARTERS
 - a) It takes about 36 days for Unaccompanied Baggage and 68 days for HHG to reach Cuba from the East Coast and 75 days for shipments from the West Coast.
 - b) Government quarters (family housing, BOQ and barracks) are often too small to accommodate the authorized weight allowance.
 - c) There is no storage available at NAVSTA Guantanamo Bay.
 - d) Disposing of excess HHG is at member's expense.
 - e) Assignment to larger quarters will not be authorized to accommodate excess HHG.
 - f) Accompanied personnel are assigned to family housing:
 - I. Quarters are equipped with refrigerator, electric range, dishwasher, guilt-in microwave and washer/dryer.
 - II. Freezers are available upon request.
 - III. Government appliances will not be removed to accommodate personally owned items.
 - IV. Personally owned appliances should not be shipped.
 - V. Loaner furnishings are available while awaiting the arrival of HHG shipment.
 - g) Unaccompanied personnel are assigned to the following:
 - I. Grades O1-O6, W1-W4, E7-E9, and GS7-GS15 to Bachelor Officers Quarters (BOQ) building 2147;
 - a. BOQ units are small efficiency style apartments which are completely furnished with a small kitchen.
 - b. Furnishings and appliances cannot be removed.
 - c. TVs, DVD players and microwaves are included and will not be removed to accommodate personally owned items.
 - d. Recommend members ship less than 1,000 pounds of unaccompanied baggage.
 - II. E4-E6 to the Bachelor Enlisted Quarters (BEQ) building 1670;
 - a. BEQ barracks 1670 are small rooms.
 - b. Equipped with a small kitchen area.
 - c. Personnel should not ship any HHG due to the small living space.
 - d. Recommend UB shipment of less than 500 pounds.
 - III. E1-E3 to (BEQ) Marine Hill Barracks 1678.
 - a. BEQ barracks 1678 are small rooms
 - b. May be assigned two to a room.
 - c. The majority of rooms do not have kitchens.
 - d. Personnel should not ship any HHG due to the small living space.
 - e. Recommend UB shipment of less than 500 pounds.
